Note – 1: The requirement shall be 02 (two) Nos light Vehicle (MUV Class) on 12 hrs basis, 5(Five) nos Ambulance (MUV Class) on 24 hrs basis .Total 07 vehicles.

Note – 2. Night Halt allowance shall be payable on account of engagement of Driver at the rate of Rs. 200/- per night for deployment of vehicle, engaged on 12 hours basis, beyond 9:00 P.M.

Note – 3. Night halt allowance shall be payable as per the certification of controlling officer of user department.

Note – 4: Engagement of Light Vehicle shall be for 3 (Three) years with a provision for extension of a further period of 1 (One) year based on satisfactory performance on mutual agreement as per the Terms & Conditions of existing contract and existing rate or the fresh tender rate for similar work, whichever is lower.

Note – 5: Diesel shall be provided by the Applicant as per the norms for required mileage as indicated in the NIA which shall be reimbursed as per the relevant norms in respect of Diesel Price for re- imbursement specified elsewhere in the NIA. EMD @ 1.25% of annualized value for offered number of vehicle is to be submitted at the time of submission of application. EMD shall bear no interest.

For Category -I (MUV Class 12 hrs): EMD shall be Rs. 4,220/- per vehicle, (MUV Class 24 hrs): EMD shall be Rs. 6,320/- per vehicle

For Category – II (MUV Classambulances): EMD shall be Rs. 6,320/- per vehicle

EMD shall be refunded to the Applicant/s who has / have not been awarded with the work on finalization of contract / work.

Eligibility Criteria:

1. The applicants should own a vehicle with commercial registration or should have acquired / booked a new vehicle and also have applied for Commercial Registration of the newly acquired / booked (prior to the date of submission of Application) light vehicle/ambulances with permit of West Bengal and Jharkhand as per the jurisdiction of Eastern Coalfields Ltd.

2. The vehicle shall not be more than 1 (One) year old from the date of issuing of NIA. w.r.t. the date of purchase of vehicle.

3. The applicant must have experience in similar nature of work (i.e. deployment of LCV on hiring basis), completed or on – going, (in their name & style) valuing 25% of the annualized value of their offered number of vehicle/s from Govt. Organisation / Semi - Govt. Organisation / Public Sector Undertaking / Joint Sector Enterprise / Public Limited Co. in Private Sector during any of the preceding seven years ending last day of the month previous to the one in which Application are invited along with certificate of satisfactory performance for engagement of such work. One year in this regard is continuous period of 365 days.

(Applicants experience (proportionate to their share as a stake holder in JV / Partnership firm) executed in Govt. Organisation / Semi - Govt. Organisation / Public Sector Undertaking / Joint Sector Enterprise / Public Limited Co. in Private Sector shall be agreeable).

4. The applicant must have minimum working capital to the tune of 20% of the annualized value of the offered work (i.e. no. of vehicle/s offered) duly certified by the practicing Chartered Accountant. Such certificate should not be more than 3 (three) months old from the date of issuing of NIA.

5. Each applicant shall be allowed to offer maximum of 3 (three) nos. of vehicles either in any single category or collectively taking into account all three categories.

Selection Criteria:

1. Offer shall be accepted only as per the rate stipulated in the NIA.

2. The vehicles shall be engaged on the basis of the age of vehicle considering date of purchase as new vehicle w.r.t. the date of publication of NIA shall be engaged first.

3. In case of a tie on age of the vehicle, award shall be made to the Applicant having more work experience in similar nature of work.

4. Further, in case of a tie in work experience, award shall be made to the Applicant having more work experience in similar nature of work in ECL.

5. In the event of a tie in respect of Sl. No. (4) above, award shall be made to the Applicant having higher amount of working capital.

6. Further, in the event of a tie in case of working capital, award shall be made through draw of lots.

Instruction to applicants

1. Applicant shall submit their offer in a sealed envelope (including EMD of required amount in a separate envelop) as per the prescribed format given in the NIA.
2. POL shall be borne by the applicant and will be reimbursed as per the norms.
3. The applicants must furnish undernoted valid documentary evidences duly self-attested in support of their eligibility:
 - a. Satisfactory Work Completion Certificate (duly issued by the principal employer) of similar nature of work with the executed value of work indicating period of work along with a copy of work order.
 - b. Working Capital Certificate duly certified by CA indicating his / her Membership No.
 - c. Copy of PAN issued in the name of Applicant.
 - d. Copy of GST registration certificate or appropriate declaration from practicing CA / Cost Accountant stating that the annual turnover of the Applicant below threshold limit of GST (i.e. Rs. 20.00 Lakhs)
 - e. Copy of the Blue Book / RC of vehicle. In case of an offer for deployment of vehicle for which order has been placed towards procurement, a copy of Invoice / Delivery advise showing status etc. issued by the concerned showroom and paper relating to submission of commercial registration fee, Challan etc. must be submitted.
 - f. Copy of Commercial Tax Token.
 - g. Copy of Commercial First party Insurance certificate of the vehicle.
 - h. Copy of pollution control certificate, as applicable.
4. Driver/Drivers should have valid Driving License and should be well disciplined, well dressed/ well behaved, punctual, must not be under the influence of drugs or alcohol during duty hours and have no criminal records. He must be acquainted with basic repairing and maintenance of the vehicle. In case of engagement for 12hrs and 24hrs is concerned the driver/drivers will be present under the controlling officer. At any point of time during the engagement of the vehicle any adverse report is put up by the Controlling Authority the work order will be cancelled without giving any reason.
5. SECURITY DEPOSIT: Performance Security (first part of security deposit) should be 6.25% of annualized value of contract amount and should be submitted within 28 days of issue of LOA by the successful Applicant will deposit the amount in favour of Eastern Coalfields Limited payable at Asansol / Salanpur as per the Bank Details given in point of **EMD** deposit and provide a bank statement duly attested by the Bank. Further, retention money shall be deducted @ 3.75% or at an applicable rate, as will be decided by the company. Total security deposit shall not exceed 10% of the annualised value of contract.
6. The Rate for hiring of light vehicle shall be firm for the entire period of contract. However, the escalation / de-escalation on account of wages and other statutory payments (i.e. Insurance & Road Tax) shall be considered on yearly basis, based on documentary

evidence. The revised values of such components shall be incorporated accordingly to derive the revised rate as issued by ECL HQ.

7. Monthly payment shall be released based on the bill duly certified by the controlling officer/user department regarding running of the vehicle during the month along with total KM run. The payment of wages to Drivers shall be made through Bank. APM(I/C) or his duly authorised representative is to certify the payment of the minimum wages as applicable and notified from time to time, based on documentary evidence submitted by the Applicant before release of Bills for payment.

8. The vehicle must be ready to ply as per requirement of work and drivers should be conversant with the traffic rules & regulations and other related regulations / norms. In case the vehicle is required to be deployed outside the operating areas of ECL, the cost incurred for any additional permission / road permit shall be reimbursed on actual basis on submission of documentary evidence.

9. Vehicle/s, deployed on 12 Hrs engagement basis at ECL Salanpur Area, should not be engaged anywhere else beyond schedule duty hours.

10. Vehicle/s engaged at ECL, Salanpur Area shall be parked either in ECL campus or anywhere within 1-2 Km from the schedule place of engagement.

11. Toll Taxes shall be paid by the applicant and will be reimbursed by the Company on submission of original receipt duly certified by the User Department.

12. POL to be provided by the Applicant and the Controlling Officer or his representative/user department will certify regarding movement of vehicle in log book on daily basis and the overall monthly kilometer run. The log Books of the outside/external agencies like police or CISF will be done by the Security Department or any other vehicle being engaged for any other purpose like CIMFR should be counter certified by Sales Department. The wages being paid by the applicant should be certified by the APM(I/C). The bills will be raised in 2 segments, Part 1 (for Hiring Charges and certified Night Halt allowances and wages paid) and Part 2 (The payment for cost of Diesel). The Diesel price will be paid on the basis of total kilometer run (as certified by user department) divided by the mileage (as mentioned above) at the price as derived from the average price of Diesel for a particular month which will be communicated by IE Department of ECL, Salanpur Area in the 1st week of succeeding month. Engine Oil will be reimbursed for @ 1 Ltr. for 500 km run. User department will certify the satisfactory performance of the work at the time of processing the Bill.

13. The eligible applicant will engage the vehicle immediately after receiving the work order.

14. Applicants must be ready to engage their vehicle anywhere under the control of ECL jurisdiction and decision of General Manager, Salanpur Area or his representation will be final regarding engagement of Vehicles.

15. Deceased/injured employees as also any person in the leasehold area of ECL as required by the security department will be carried in the ambulances. The mobile nos of the ambulances will be provided to the central control room under security department and will be made available for 24 hrs.
