The nature of engagement, term and conditions are as follows:-

The decision of the Tender Committee will be final and binding in such cases.

Separate sealed covers in part-I and Part-2, clearly indicating the part number and name of the tenderer on the right side of the covers should reach to the office of the General Manager (E&M), Central Hospital, Kalla at the above address by 1.00 P.M./ on 15.03.18. The part one envelope will be opened by the Tender Committee on the same day at 3.00 P.M. and the name of the successful tenderers as per Part-I will be enlisted by the Tender Committee. The Part-2 document of such successful tenderer in Part-I will only be opened and the rest will automatically stand rejected. This will be binding to all concerned strictly.

Tender number, date & name of the tenderer must be mentioned clearly in block letter on the envelope including part number. Towards earnest money, the tenderer should deposit a sum of Rs. 5866/- (Rupees Five thousand Eight hundred Sixty Six) only for 9seater one years old vehicle within the due date as noted above to the Chief Cashier of office of CMS I/C CH Kalla ECL and receipt obtained In original must be enclosed with the documents of part I envelope and the tender without earnest money receipt will be rejected.

- 3) Copy of Valid Road Tax payment certificate duly countersigned by the tenderer concerned.
- 4) Copy of Valid Insurance payment certificate duly countersigned by the tenderer concerned.
- 5) Copy of Valid Pollution Control certificate.
- 6) Copy of certificate of registration under M.V. authorities to use the vehicle for commercial purpose duly countersigned by the tenderer concerned.

- 8) Valid fitness certificate issued by R.T.O

The offer of hiring charges per day i.e.

**IMPORTANT NOTES**

After verifying the entries made over the sealed envelope, Part-I document (sealed envelope) will be opened first and the successful bidders of the part-I documents will be only considered for opening their part 2 envelope.

**TERMS AND CONDITIONS:-**

- a. Diesel and mobile of the vehicle will be provided by the company as quoted by the agency in the prescribed proforma.
- b. The vehicle must be made available for 24 hours during 730 days of two years.
- c. It will be the responsibility of the tenderer to ensure safety of travelers including the driver.
- d. Excepting the driver, no other person of the tenderer will be allowed to travel in the vehicle.
- e. Issuance of work order is subject to physical verification/inspection of the vehicle by the T.C.members and approval of the competent authority.
- f. The vehicle owners can apply only if he possess at list 3years experience as credential of running the vehicle for the purpose of Hospital, Girls Nursing School / Hostel, Girls School / Hostel. It will be treated as compulsory for qualifying in Part-II (Price bid) of the above tender
- g. The driver will have mobile phone connection and the number will have to be given to the office for easier communication.
- h. In case of break-down of the vehicle, the tenderer shall arrange for a replacement immediately failing which penalty may be imposed as deem fit.
- i. **Security deposit as per NIT:- Security Money 10% (included earnest money of above work order value), should be deposited before engagement of the vehicle, in the form of DD in favour of C.H.Kalla (ECL), State Bank of India payable at Asansol**
