(ii) Two similar completed works each costing not less than 50 % of respective estimated cost.

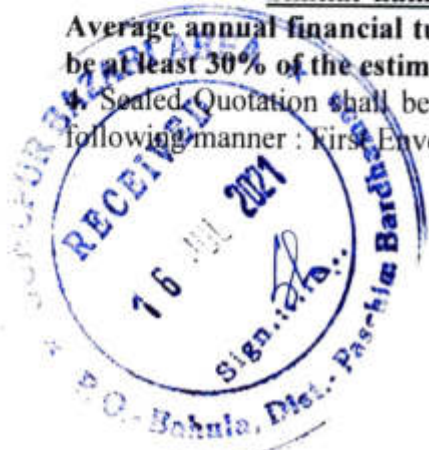
