1) 1.TYPE OF TENDER

Tenders are invited in **single stage single envelope/cover system** with the TENDER NUMBER, DUE DATE OF OPENING, NAME OF WORKS and it should be put in the tender box provided in the office of Area Engineer (Excavation), S.P. Mines Area(Excavation Department, S.P.Mines Area), P.O: Chitra, Distt: Deoghar, Jharkhand, Pin: 815351. Quotation will contain price bid only including charges for job/work in break up form, indicating actual cost of individual materials along with grade and quantities, labour, charges, taxes, profit, testing, etc charges, and any other charges for arriving at total landed cost. Rates must be quoted in figures as well as in words, duly signed with seal. Technical Parameters, documentary evidence in supporting of credentials for past work experience supported with work order copies in same/ similar job and commercial terms and conditions and description of job and scope of work as mentioned above. Tender document will be available from the office of the Area Engine

(Excavation). It will be supplied on free of cost on demand subject to be available to show all the relevant documents on above schedule working days except Sunday and Holiday and on Saturday from 10 AM to 12:30 PM. Also tender document will be available from the website of www.easterncoal.gov.in.

2.TENDER EVALUATION.

The documents submitted by bidder will be evaluated by the tender committee. L-1 bidder qualified in technical scrutiny and if it confirms to all of the NIT terms and conditions by the bidder then the bidder will be eligible for award of Contract. In case the tender committee finds that there is some deficiency in submitted documents or in case corresponding document have not been submitted by the L-1 bidder, then the same will be specified by Evaluator clearly indicating the omission/shortcomings in the submitted documents and indicating start date and end date allowing seven days (7 X 24 hours) time for resubmission by L-1 bidder. The L-I bidder will get this information on the address and email ID provided on his letter head, but it will be the bidders responsibility to check the information on their email ID or address. In case the L-I bidder fails to submit requisite documents as per NIT or if any of the information/declaration furnished by L-I bidder is found to be wrong by Tender Committee during evaluation of documents submitted by bidder, than his bid shall be rejected and EMD of L-I bidder will be forfeited and tender shall be re-tendered (with the same or different quantity as per the instant requirement).

- 3) Tenderers are required to deposit the requisite amount of earnest money (EMD) in form of DemandDraft/B Cheque to the Cashier, S.P. Mines Area. B CHEQUE/DD drawn in favour of EASTERN COALFIELDS LIMITED, A/C S.P. Mines on any nationalized bank payable at Chitra(Preferably on S.B.I) & same should be submitted with the bid in a sealed cover. - 9) **Warranty** should be minimum 6 months/1500 working hrs from the date of repairing /handing over the job after repair, whichever is earlier.
- 10) Photocopy of CMPF Registration," CMPF registration is must for all contractors. - 11) CLIP Registration under Coal India Website is must for all the contractors. In case contractor has not applied for CLIP Registration earlier & they have no work order then, they must apply for CLIP Registration after getting Work Order within 10 days of allotment of Work Order, otherwise bill will not be processed."
- 12) Taxes must be mentioned clearly as applicable on the date of tender submission. Offer L-1 will be considered incl. of all taxes.
