Terms & Condition: -

- 1. Type of Tender:** - Tenders are invited in single part system. Tender will contain terms and conditions of contract and documentary evidence in support of credentials of the tenderers, and price bid. Tender must be super scribed with the TENDER NO, DUE DATE OF OPENING, NAME OF WORKS and it should be put in the Tender Box provided in the office of Safety Officer, Sonapur Bazari Project, ECL. BILL OF QUANTITIES & OTHER TENDER DOCUMENTS will be available from the office of the Safety Officer, Sonapur Bazari Project, ECL. The documents related to NIT including BOQ will be issued at free of cost to the interested contractors during the office hours from 10 am to 1.00 pm during all working days except Sunday & Holiday against written application.

2. ELIGIBILITY CRITERIA:

1. (a) Experience of having successfully completed similar works as a prime contractor with a GOVT./ SEMI GOVT./PRIVATE department during the last seven years ending last day of the month previous to the one in which tenders are invited should be either of the following. Three similar completed works each costing not less than the amount equal to 40% of the estimated cost. **OR** Two similar completed works each costing not less than the amount equal to 50% of the estimated cost. **OR** One similar completed work costing not less than the amount equal to 80% of the estimated cost. The party should have experience in similar type of job as mentioned below.

Definition of Similar nature of Work. (i) Refilling and reconditioning of any type of Fire Extinguishers in any mine

The intending tenderers must submit documentary evidence in support of above in the form of (a) Certified copy of Work Order, completion certificate/payment Certificates indicating the period of work for which the payment has been made. (b) Photocopy of Valid PAN. (c) Photocopy of Valid GSTIN. (d) Photocopy of Valid CMPF Certificate.

3. Earnest Money Deposit (EMD):

Earnest Money (@ 1.25% of the estimated cost, including GST, of work put to tender rounded off next to hundred) should be deposited by the participating bidder by way of Demand Draft in favor of "EASTERN COALFIELDS LIMITED A/C SONEPUR BAZARI AREA" payable at State Bank of India, Asansol. The EMD shall be refunded to the unsuccessful bidders after finalization and award of work and shall bear no interest. This shall be deposited in the manner as described in the procurement guideline. EMD received in the form of Bankers Cheque/ bank Draft shall be deposited to the associated Accounts Department. There shall be no EMD in case of Single tender.

TECHNO COMMERCIAL BID. The EMD before the date of NIT will not be accepted and subsequently no submission of the EMD will lead to the no opening of Bid that eventually lead to the rejection of bid.

4. Tender documents collection Start Date is on and from 06.11.2025 to 15.11.2025 between 10 AM to 1 PM. Date of submission of tender is on 15.11.2025 from 10 am to 1 PM and Quotations will be opened on 15.11.2025 at 3.30 PM in the presence of the intending tenderers or their representatives. Contractors are to submit Xerox copy of Pan No, GST registration, LEGAL STATUS OF THE BIDDER (Document(s) covered under any one of the following sub-head(s): i. Affidavit or any other document to prove proprietorship/Individual status of the bidder ii. Partnership deed containing name of partners.iii. Memorandum & Article of Association with certificate of incorporation containing name of bidder) and job completion proof for experience certificate. (GST applicable as per extended rule) along with BOQ/commercial bid.

5. Accommodation of workers of the contractor shall have to be arranged by the contractor of his own. All safety rules and regulations have to be abide by the contractor which is applicable for coal mines. All General Terms and Conditions of ECL will have to be abided by the contractor and the contractor is to pay his worker staff as per Contract Labour (Regulation/ Abolition) ACT 1970 and further amended thereafter and have to pay any compensation to them due to accident or for any other reason. In other words, you have to obtain and submit necessary certificate of Registration/ License under Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (Regulation Abolition) Act 1970 central rules and latest amendment thereof as well as that for EPF & ESI as applicable. However, the bids of the bidders who have applied for CMPF Registration but the allotment has not yet been conveyed will be accepted on production of proof applying for CMPF registration at the time of submission of Tender. Valid license under provision of Contractor Labour (R&A) Act 1970 is to be submitted. ECL management will not be responsible for the contractor and his workers/staffs for any untoward accident/incident. No medical aid will be provided to the contractor and his workers/staffs by ECL management. It shall be the responsibility of the contractor to ensure that every workman deployed by him for completing the contract has undergone BASIC TRAINING or REFRESHER TRAINING and initial Medical Examination as required by Mines Act 1952..

6. **PERFORMANCE GUARANTEE & PAYMENT TERMS:** Contractor has to give a performance Guarantee for one year from the date of handing over the job to ECL after satisfactory completion. Any defect either quality of the materials or fabrication, the contractor has to set it right free of cost after receipt of information during Guarantee period. 90% of the total work value shall be paid to the contractor within 30 days from the submission of the Bill after job duly certified by the Safety Officer, Sonepur Bazari Project. Rest 10 % will be paid after expiry of the Guarantee period with satisfactory performances.

7. Rates must be quoted in figures as well as in words duly signed with seal.

8. **Paying Authority:** Area Finance Manager, Sonepur Bazari Area.

9. All other contract and Safety rules of ECL will be applied in this case.

10. Tools and tackles etc. are to be arranged by the contractor.

11. L/D considered @ ½ % per week subject to maximum 10 % of undelivered / unexecuted portion of the work will be applicable if the work is not completed within the stipulated period.

12. However ECL management reserves the right to consider for the extension of time if felt necessary under some unavoidable circumstances and adverse conditions. If the execution of the job is abandoned by contractor, the same will be completed with prior intimation to the contractor by other agencies as per rate prevailing at the contractor's cost.

13. Contractor must engage competent persons during working period.

14. The offer should be valid for **120 days**.

15. The management deserves the right to reject the Tender wholly or partly without assigning any reasons whatsoever.

16. In case of Date of opening falls on **Holidays or BANDH** paralyzing the local communication, the due date and time of receipt of Tender and Date of opening of Tender shall be deferred to next working day(s).

18. Quotations erased and overwriting will be rejected unless corrections are authenticated with the tenderer's signatures.

19. Mode of Submission of Tenders: -

All the sealed envelopes i.e., containing a) Part-I, b) Part-II are to be placed in a single envelope and sealed and submitted accordingly. The management reserves the right to reject any or all the tenders without assigning any reason whatsoever and to split up the work between two or more tenderers or accept tender in Part and not in entirety.

20. OTHER INSTRUCTIONS-

The work is to be done in strict compliance with the technical specifications mentioned in the BOQ. Mere issue of tender documents to intending bidders will not mean that they have fulfilled the requisite qualifications. Tender documents duly filled in, as required, and signed on each page are to be submitted by the tenderers. Incomplete tender documents not completely filled in shall be summarily rejected. Also, non-submission of issued tender documents will lead to summary rejection of tender. The photo copies of all certificates submitted shall be legible and duly signed by tenderers. Each copy should be duly self-attested. A late tender shall not be accepted at all without any exceptions. Tender documents shall not be issued or received by post. The other terms & conditions of NIT covered under this document will be as per the manual of Safety works of CIL and Manual for e-procurement of Works and Services in CIL and subsequent amendments thereafter, which may be seen on www.coalindia.in and www.easterncoal.nic.in.
