Sub: Banning of Business with M/s H.R. Industries

Ref: (i) Our Purchase order no. 05840046(02) dated 16.09.2020 for supply of 532 nos Standard Coal Tubs

(ii)Our Show Cause Notice No. ECL/MM/Hq/Pur/03/Show Cause/259 dated 25.07.2022

With reference to the above, a Show Cause Notice vide letter No. ECL/MM/Hq/Pur/03/ Show Cause/259 dated 25.07.2022 was issued to you as inspite of repeated requests and delivery extension, you had only partially executed the contract i.e. only 176 nos Standard Coal Tubs against order quantity of 532 nos. Hence penal action i.e. Banning of Business is applicable under the following clauses of CIL Purchase Manual 2020,

Clause 6.13.2 (xi):

Continued and repeated failure to meet contractual obligation. Clause 6.13.2 (xiv):

Any other misdeed, which may cause financial loss or commercial disadvantage to the Company.

An opportunity was given to you to submit a written statement of defense with relevant documents, if any, within 21 days of the issue of this Show Cause Notice.

In terms of referred Show Cause Notice, a reply has been submitted by you vide letter no. HRI/22-23/124 dated. 18.08.2022.

On examination of above reply, it is found that statement of defense as submitted by you is not considered acceptable and not found satisfactory. The charges levelled against you as detailed in the referred Show Cause Notice are substantiated.

Consequent to above, taking a serious view of misconduct on part of M/s H.R. Industries, Chattisgarh, the Competent Authority of Eastern Coalfields Limited has decided to impose "Banning of Business" with your Organisation for a period of two years from the date of issue of this letter.

Industries, Chattisgarh is hereby banned in Eastern Coalfields Limited for a period of two years from the date of issue of this letter in line with the provision of CIL Purchase Manual 2020. However, you shall be allowed to participate only in the Risk Purchase Tender against the Purchase order No. 05840046(02) dated 16.09.2020 as per provision of clause 19.19.3 (iv) of CIL Purchase Manual 2020.
