Subject: Debarment of M/s Amrit Cargo Private Limited for the period of One (01) year from participation in future tenders of ECL

Dear Sir,

You were awarded the subject work “*Contractual Transportation of 1,16,600 Te coal from Tippler of Belbaid Colliery to Parasea Railway siding via weighbridge and 58,300 Te coal to stock yard of Belbaid Colliery (Lead: 3-4/0-1 km) and Loading of 58,300 Te coal by payloader into tippers at stock yard of Belbaid Colliery and Transportation of 58,300 Te coal from stock yard of Belbaid Colliery to Parasea Railway siding via weighbridge under Kunustoria Area for the period of 02 (Two) years (Lead: 3-4 km)*” vide LOA Ref. No. GM-KNT/LOA/Coal/23-24/285, Date: 06.12.2023, with competent approval on TC recommendation.

Despite sufficient availability of coal, you did not satisfactorily transport the coal from Belbaid Colliery to Parasea Railway Siding in accordance with the awarded WO. Your non-performance has not only affected the coal production but also endangered safety of the mine by causing chance of spontaneous heating due to non- transportation of coal.

During execution of the awarded work, in last three consecutive months your monthly performance was less than 70%, attracting Clause 9(b) of Conditions of Contracts of the NIT, which reads as ***“The Company shall, in addition to other remedial steps to be taken as provided in the Conditions of Contract, be entitled to cancel/terminate the contract in full or in part, if the Contractor fails to achieve a monthly agreed quantity of 70% (Seventy percent) for a period of 3(three) consecutive month or for cumulative period of 3(three) months within any continuous period of 18(eighteen) months, save and except to the extent of non-availability caused by i) a Force Majeure event or ii) an act of omission of Company, not occurring due to any default of the Contractor.*”**

Note: - In such cases the Contractor may be debarred for minimum one year from participating in future bidding allowing the present business to continue without going into termination of the contract.”

Instead of all the above communication you did not make any improvement rather the performance has degraded with passing time, resulting huge coal stock at coal depot of Belbaid Colliery. Subsequently, in accordance with aforesaid Clause 9(b) of Conditions of Contracts of the NIT, the contract in respect of the said work had been terminated vide letter GM-KNT/CMC/25-26/624, dated: 01.04.2025.

Keeping in view principle of natural justice, you were called for personal hearing at the Office of the General Manager, Kunustoria Area, for personal hearing on 25.04.2025 vide letter GM-KNT/25-26/228, dated: 15.04.2025. In your appearance at the Office of the General Manager, Kunustoria Area on the said date you could not provide any substantial justification for not banning the firm for participating in future bidding.

In addition to previously stated provision i.e. Clause 9(b) of Conditions of Contracts of the NIT, you / your firm is liable for debarment from future bidding as per condition stated in Clause 2(V) of Guidelines on Debarment of Firms from Bidding of the NIT, which reads as ***“Continued and repeated failure to meet contractual obligations: a. In case of partial failure on performance, agency shall be debarred from future participation in tenders keeping his present contract alive. b. On termination of contract.”***

This is to inform you that in light of the above facts and incidents **M/S AMRIT CARGO PRIVATE LIMITED** is hereby debarred from participating in any future tenders of Eastern Coalfields Limited (ECL) for a period of one (01) year, effective from the date of issuance of this letter.
