Dear Sir,

You were awarded the subject work "Hiring of 01 no. of water tanker/sprinkler 12KL capacity with self-loading arrangement for Barmuri OCP and nearby areas for a period of 01 year (365 days)" vide LOA Ref. No. ECL/GM/MA/ADMN/24-25/263, dated 26.12.2024.

As per Clause 4.2 of Section-II, General Terms and Conditions of the NIT, you were required to submit the Performance Security Deposit (PSD) within 21 days of the issuance of the LOA. Despite multiple communications (referenced above), you failed to submit the PSD amount within the stipulated time period and also failed to execute the said work.

Your failure to comply with the contractual obligations led to the cancellation and termination of the instant contract vide letter no. ECL/GM/MA/CT/24-25/147 dated 18.02.2025, in accordance with the terms of the NIT.

In line with the principles of natural justice, you were given sufficient opportunities to rectify the default through the letters mentioned above, but no response was received from nor any personal hearing was requested from your end.

**The terms "banning of firm", 'Suspension', 'Blacklisting' etc. convey the same meaning as of 'Debarment'. – (Amended Section/Clause-2)**

Your firm is liable for debarment as per the condition stated in Clause 4.3 of Section-II, General Terms and Conditions of the NIT, which reads as follows:

*"In case the successful Bidder fails to submit the Performance Security and Additional Performance Security, if any, within the stipulated time then the award of work may be cancelled with forfeiture of the Bid Security/Earnest Money. Additionally, the Company shall debar such defaulting Contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter..."*

This is to inform you that in light of the above facts,

**M/s Abhay Sharma (Proprietor: Abhay Sharma, PAN: SHWPS5740G)** is hereby debarred from participating in any future tenders of Eastern Coalfields Limited (ECL) for a period of **one (01) year**, effective from the date of issuance of this letter i.e. from 15/09/2025 to 14/09/2026.
